

Enzo Bogus Caller Technical Guide



Introduction

A bogus caller button enables a person to raise an alarm if they get unwanted visitors. For anyone concerned about the potential risks of unwanted callers, an Enzo bogus caller button installed on or beside the door can provide extra peace of mind. This wireless emergency panic button allows the user to easily and discreetly place an alarm call to Careium if they feel uneasy about, or threatened by, someone at the door. The bogus caller button has two-way data communication which means the user receives a confirmation that the alarm has been acknowledged. When the button is pressed, the LED indicator lights up. When the base alarm receives the signal from the button, this is confirmed by the indicator light changing color.

The bogus caller button is compatible with all of Careium's current base units: CareIP® Mobile, CareMobile, Eliza & Eliza S.

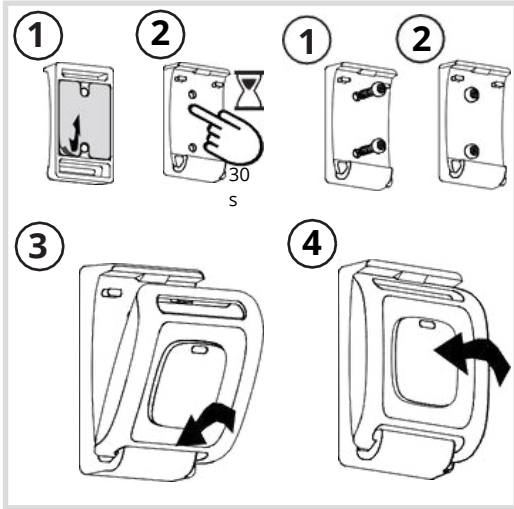
- LED indicates transmission and battery status. Range covers a normal house or flat.

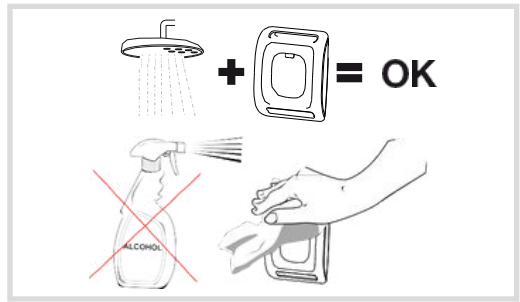
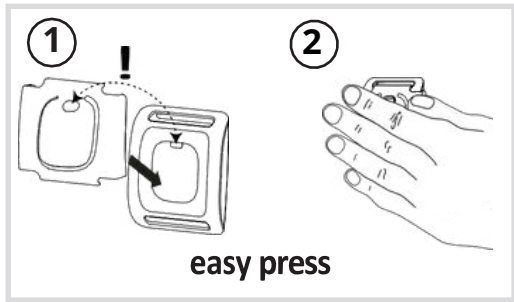
